Report on the 2013 Financial Statements of CIC Crown Corporations and Related Entities

1.0 PURPOSE

The purpose of this Report is to inform the Legislative Assembly of our Office's views on the financial statements of Crown Investments Corporation of Saskatchewan (CIC), its subsidiary Crown corporations, and other related entities. Our views on the financial statements of other Crown agencies are presented in a separate report.

2.0 BACKGROUND

The Assembly allows the Government to appoint auditors to examine and report on Crown agencies. The Provincial Auditor, however, retains overall responsibility for the audits of all Crown corporations.

In June 1994, the *Report of the Task Force on Roles, Responsibilities and Duties of Auditors*¹ recommended how the audit system for CIC and its subsidiary Crown corporations could function more efficiently and effectively. Our Office, CIC, CIC subsidiary Crown corporations, and other related entities and appointed auditors are using those recommendations to better serve the Assembly's needs. The Task Force recommended that we give the Assembly a report listing the CIC Crown corporations in whose audits we participated.

The objectives of each audit are to form the following opinions and to report the results to the Assembly.

- › An opinion on the rules and procedures used by the agency to safeguard public resources.
- › An opinion on the agency's compliance with the authorities governing its activities related to financial reporting, safeguarding public resources, revenue raising, spending, borrowing, and investing.
- › An opinion on the reliability of the agency's financial statements.

In our *2014 Report – Volume 1*, we will report the results of the 2013 audits. The appointed auditors' reports on the reliability of CIC, and on each CIC subsidiary Crown corporation's and other related entity's financial statements accompany the respective financial statements.

The Government's summary financial statements include the financial results of all Crown agencies controlled by the Government. *Public Accounts 2012-13 – Volume 1* includes my auditor's report on the Government's Summary Financial Statements for the year ended March 31, 2013.

3.0 RESULTS

We participated in the financial statement audits of CIC and all CIC subsidiary Crown corporations and other related entities except as noted in **Figure 1**. CIC, CIC subsidiary Crown corporations, and other related entities each have a December 31 fiscal year end. In our opinion, for the audits we participated in, the 2013 financial statements are reliable.

Figure 1 lists CIC, CIC subsidiary Crown corporations and other related entities whose financial statements are audited by appointed auditor, the appointed auditor's name, whether we participated in the audit, and whether the 2013 financial statements are reliable.
